Agreement dated as of _____ between _____ (hereinafter referred to as "CLIENT") and Evidence Video Investigations, Inc. (hereinafter referred to as "AGENCY")

1. It is agreed that CLIENT will furnish AGENCY with true and accurate information to the best of CLIENTS knowledge and ability at the time of this agreement. AGENCY reserves the right to decline, or withdraw from, any assignment that might give rise to a conflict without explanation. CLIENT understands and agrees that knowingly supplying false, misleading or incomplete statements or information to AGENCY relating to said assignment will result in immediate termination of said assignment and forfeiture of all retainers and money paid to AGENCY.

2. AGENCY does not draw conclusions, makes representations, nor expresses any opinions regarding the information contained in Investigative reports. CLIENT acknowledges that the information contained in such reports is obtained from sources including, but not limited to: public records, commercial databases, nonproprietary services and through observation or perception, which may require the exercise of judgment of interpretation. Name similarities may be included in public records, investigative reports and commercial databases; due to lack of sufficient information to verify that the individual or entity is the MISSING PERSON of research. CLIENT agrees that all reports will be submitted and received are subject to the conditions of this Agreement. By requesting and receiving reports, the CLIENT agrees to indemnify and hold harmless AGENCY, its officers, and employees from any and all claims, liabilities, expenses, fees including attorney fees, costs, and judgments arising from CLIENTS use or possession of the information furnished in said reports. Reports may be delivered via US Mail; faxed upon consent of CLIENT; hand delivered and/or delivered telephonically or electronically via email. CLIENT requests a written report, _____ YES, _____ NO

3. NO action will be initiated on any case, without an appropriate retainer which will be applied to the fees incurred. CLIENT agrees to pay AGENCY for all services rendered, without regard to outcome. CLIENT agrees to pay AGENCY a retainer in the amount of **\$ 375.00 (THREE HUNDRED SEVENTY-FIVE DOLLARS)** in full to secure services before AGENCY shall commence work.

4. Pursuant to Florida Statutes Chapter 493.6119 (1), AGENCY will keep and maintain all reports strictly confidential, regardless of how delivered to client. Except where required by law, no information from reports will be revealed to ANY third party without CLIENT expressed written consent or upon order of Court of competent jurisdiction.

5. In the process of obtaining requested information, AGENCY will comply with all provisions of Federal, State, and Local laws and regulations pertaining to the use of criminal conviction histories and/or bank account or confidential financial information and adhere to all current privacy rules and regulations. AGENCY assumes that all information provided to CLIENT will be used for lawful purposes only and CLIENT acknowledges that he/she has represented such to AGENCY.

6. CLIENT agrees and understands that AGENCY will endeavor to locate MISSING PERSON within **thirty days** from the date of receipt of this contract and retainer through any legal means available, and if successful, will contact MISSING PERSON by any means possible for the purpose of reuniting the MISSING PERSON and CLIENT. If CLIENT does not have a retained Attorney then AGENCY will obtain the MISSING PERSONS express permission to release his or her contact details to CLIENT. If this matter is confidential in nature and there is no CLIENT-Represented Attorney, then it is understood that at the time contact with MISSING PERSON is made, AGENCY shall furnish MISSING PERSON with CLIENT'S full name and contact details, otherwise info will be held confidential until legal counsel is made.

7. If not confidential in nature, CLIENT agrees and understands that, in the event that MISSING PERSON refuses permission for AGENCY to release their contact information to CLIENT, and/or indicates that they do not wish to renew any form of contact with CLIENT, then AGENCY will **under no circumstances** release the MISSING PERSON'S contact information, or any other information pertaining to this investigation, or results of any part of this investigation to CLIENT, and the case shall be considered successful and closed. It is also understood that if this investigation reveals that the MISSING PERSON is now deceased or in the event that AGENCY is unsuccessful in this endeavor, the case shall be considered successful and closed.

8. By requesting and receiving the results of this investigation, the CLIENT agrees to indemnify and hold harmless AGENCY, its officers, and employees from any and all claims, liabilities, expenses, fees including attorney fees, costs, and judgments arising from CLIENTS use or possession of the information furnished by AGENCY. It is agreed that any and all court appearances pertaining to this case will be billed to CLIENT at the rate of \$75 (SEVENTY FIVE DOLLARS) per hour plus associated expenses.
